POST-ARREST COMPLAINT

Charge: OPER MTR VEHICLE U/INFLUENCE ALC/DRUGS/ETC. 08 - 1ST OFF

Officers received dispatched complaint in reference to a possible intoxicated driver traveling north bound on the Bypass from the Snel Station near the Bluegrass Parkway with Texas registration plates. Officer M. Corley observed the vehicle swerving in the roadway and conducted a traffic stop. As the stop was being conducted I went in route to assist Officer Corley. Upon my arrival I spoke with the operator and detected a strong odor of an alcoholic beverage on his person, with red glassy eyes and slurred speech. I asked the subject for his insurance and he stated it was in his golf bag and needed to get out. During the exit he used the door for balance and was confused on how to open the trunk. The insurance was not in the bag and he went to the passenger side. He was confused about how to unlock the vehicle and took several tries to unlock the glove box. He was still unable to find his insurance. Subject refused a PBT, stated he had feet problems and balance problems HGN +

NARRATIVE

On Thursday, August 27, 2009 at approximately 0224, I was dispatched to 127 Bypass in reference to a possible intoxicated driver in a white four door car with Texas registration plates traveling north bound on 27 Bypass coming from the Shell station near the Bluegrass Parkway. As I was heading south on 127 I passed a white four door vehicle traveling north just passed the intersection with Carlton dr which I clocked with moving radar at 63mph in a 45mph zone. I turned around and finally caught up with the vehicle as it was stopped at a red light at the intersection with highway 62, the vehicle did have Texas registration plates, when the light turned green it took one to two minutes before the vehicle continued north on 127 in the left lane. As I followed the vehicle I noticed that it was weaving badly in its lane, and was constantly crossing over the center line and the fog line. I followed about 3 car links behind the vehicle as it would speed up to around 55mph hit the brakes and slowdown to about 50mph the vehicle did this several times between 62 and the entrance to the Anderson County Park. After we passed the entrance to the county park I ran the registration plates which came back to a white 2009 Mercedes Benz owned by a Billy C. Gillispie at 621 West Division, Graford TX, 76449. I then activated my lights and conducted a traffic stop with the above vehicle at the entrance to the new Emma B Ward school on 127, the vehicle hit its brakes and quickly pulled off in the emergency lane where it continued north for nearly a half mile before it finally came to a complete stop just passed the Brier Wood subdivision. Upon approach of the vehicle I spoke with the driver Billy Gillispie, Billy had a strong fruity smell coming from his person (possibly wine) and had red glassy eyes and slow slurred speech. I asked Billy for his license and proof of insurance he stated that his insurance was in a bag in his trunk, he then stepped out of the vehicle using the door for balance and walked to the trunk being very unsteady on his feet, Billy took a minute to open the trunk and was unable to find his insurance. I asked Billy if he had had any thing to drink tonight he stated no he had been golfing all day, I then asked him if he would take a preliminary breath test to rule out the presents alcohol he refused the test. I then attempted to conduct the SFST on him and he refused it also. I then waited for a unit with in car video at witch SGT. C. Powell showed up and took over the traffic stop.
