COUNT 1.

Between January 1, 2008 and December 31, 2008, in Fayette County, Kentucky, the above named Defendant, Michael Gobb, committed the offense of Theft by Deception over \$300 by unlawfully creating and/or reinforcing a false impression to obtain property and/or services valued at more than \$500, to wit: he placed charges on the credit card issued to him from Bluegrass Airport in order to obtain items for personal use;

COUNT 2:

Between January 1, 2007 and December 31, 2007, in Fayette County, Kentucky, the above named Defendant, Michael Gobb, committed the offense of Theft by Deception over \$300 by unlawfully creating and/or reinforcing a false impression to obtain property and/or services valued at more than \$500, to wit: he placed charges on the credit card issued to him from Bluegrass Airport in order to obtain items for personal use;

COUNT 3:

Between January 1, 2006 and December 31, 2006, in Fayette County, Kentucky, the above named Defendant, Michael Gobb, committed the offense of Theft by Deception over \$300 by unlawfully creating and/or reinforcing a false impression to obtain property and/or services valued at more than \$500, to wit: he placed charges on the credit card issued to him from Bluegrass Airport in order to obtain items for personal use;

COUNT 4.

Between January 1, 2005 and December 31, 2005, in Fayette County, Kentucky, the above named Defendant, Michael Gobb, committed the offense of Theft by Deception over \$300 by unlawfully creating and/or reinforcing a false impression to obtain property and/or services valued at more than \$500, to wit: he placed charges on the credit card issued to him from

Bluegrass Airport in order to obtain items for personal use;

COUNT 5:

Between January 1, 2003 and December 31, 2003, in Fayette County, Kentucky, the above named Defendant, Michael Gobb, committed the offense of Theft by Deception over \$300 by unlawfully creating and/or reinforcing a false impression to obtain property and/or services valued at more than \$500, to wit: he placed charges on the credit card issued to him from Bluegrass Airport in order to obtain items for personal use;

COUNT 6:

Between April of 2004 and January of 2009, in Fayette County, Kentucky, the above named Defendant, Michael Gobb, committed the offense of Theft by Deception over \$300 by unlawfully creating and/or reinforcing a false impression to obtain property and/or services from valued at more than \$500, to wit: by obtaining reimbursement from Bluegrass Airport for property and/or services that were for personal use;

COUNT 7:

Between January 1, 2008 and December 31, 2008, in Fayette County, Kentucky, the above named Defendant, John Rhodes, committed the offense of Theft By Deception Over \$300 by unlawfully creating and/or reinforcing a false impression to obtain property and/or services valued at more than \$500, to wit: he placed charges on the credit card issued to him from Bluegrass Airport in order to obtain items for personal use;

COUNT 8:

Between January 1, 2006 and December 31, 2006, in Fayette County, Kentucky, the above named Defendant, John Rhodes, committed the offense of Theft By Deception Over \$300 when he created and/or reinforced a false impression to obtain property and/or services valued at more than \$500, to wit: he placed charges on the credit card issued to him from Bluegrass Airport in order to obtain items for personal use;

COUNT 9:

Between January 1, 2005 and December 31, 2005, in Fayette County, Kentucky, the above named Defendant, John Rhodes, committed the offense of Theft By Deception Over \$300 when he created and/or reinforced a false impression to obtain property and/or services valued at more than \$500, to wit: he placed charges on the credit card issued to him from Bluegrass Airport in order to obtain items for personal use;

Between January 1, 2004 and December 31, 2004, in Fayette County, Kentucky, the above named Defendant, John Rhodes, committed the offense of Theft By Deception Over \$300 when he created and/or reinforced a false impression to obtain property and/or services valued at more than \$500, to wit: he placed charges on the credit card issued to him from Bluegrass Airport in order to obtain items for personal use;

COUNT 11:

Between January 1, 2003 and December 31, 2003, in Fayette County, Kentucky, the above named Defendant, John Rhodes, committed the offense of Theft By Deception Over \$300 when he created and/or reinforced a false impression to obtain property and/or services valued at more than \$500, to wit: he placed charges on the credit card issued to him from Bluegrass Airport in order to obtain items for personal use;

COUNT 12:

Between January 1, 2002 and December 31, 2002, in Fayette County, Kentucky, the above named Defendant, John Rhodes, committed the offense of Theft By Deception Over \$300 when he created and/or reinforced a false impression to obtain property and/or services valued at more than \$500, to wit: he placed charges on the credit card issued to him from Bluegrass Airport in order to obtain items for personal use;

COUNT 13:

From November 2008 until December 2008, in Fayette County, Kentucky, the above named Defendant, Michael Gobb, committed the offense of Theft by Deception over \$300 by unlawfully creating and/or reinforcing a false impression to obtain property and/or services valued at more than \$500, to wit: by placing a charge on John Coon's airport credit card to obtain property for which the Defendant, Michael Gobb, was not entitled;

COUNT 14:

From July 2006 until August 2006, in Fayette County, Kentucky, the above named Defendant, Michael Gobb, committed the offense of Theft by Deception over \$300 by unlawfully creating and/or reinforcing a false impression to obtain property and/or services valued at more than \$500, to wit: by instructing Amy Caudill to place a charge on her airport credit card to obtain property for which the Defendant, Michael Gobb, was not entitled;

COUNT 15:

From November 2004 until December 2004, in Fayette County, Kentucky, the above named Defendants, John Coon, Michael Gobb, and John Slone, committed the offense of Theft By Deception over \$300 by unlawfully creating and/or reinforcing a false impression to obtain property and/or services valued at more than \$500, to wit: the defendants John Coon, John Slone, and Mike Gobb agreed that John Slone would fraudulently submit a credit card charge to be authorized for payment by Michael Gobb of unauthorized goods and/or services which the defendants had obtained at Millenium Restaurants;

against the peace and dignity of the Commonwealth of Kentucky.
